The following policy reflects our concern for your child’s physical welfare. We cannot admit your child without your consent to this waiver.

Holistic Atelier – San Diego is NOT responsible for children before or after the hours for which they are registered for session. Parents and children are welcome to enter Holistic Atelier studio at the program’s stated start time. Each session’s fees however, only covers the art session time and does not include supervision before or after hours.

Holistic Atelier – San Diego reserves the right to require parents or guardians to withdraw a child from session for disruptive behavior at any time.

Additional Notes:

1- Please, do not allow your kid to bring to session anything of value that can be lost or damaged.

2- Holistic Atelier –SD is an art studio where children are allowed to make messes. Do not let your child wear expensive or delicate clothing since there is a chance they could be damaged.
